Please see our proposal below:


- Saw cut roadway and driveway area.
- Remove blacktop.
- Excavate area to remove deteriorated piping approx. 8'-10' depth.
- Install new HDPE pipe entire length from basin on corner to double basin at end of road.
- Backfill with $\frac{3}{4}$ " stone and material excavated.
- Compact all trenches.
- Excavate roadway where sinkhole is located. Reinstall all base material and compact.
- Repave areas disturbed as per town spec.
- Repair lawn areas with seed and straw.

Cost = \$34,360.00

- Backfill lawn area with dirt excavated.
- Apply topsoil where needed seed and straw.
