The Deputy Mayor and Village Trustees reviewed the tentative 2020 Budget. They discussed all lines of the budget and requested information regarding various lines from the Village Clerk. There was a discussion regarding a 3.5% salary increase for certain employees and elected officials. Trustees Blunnie, Pesante and Warbrick were in favor of an increase and Deputy Mayor Downey was opposed.

A decrease in certain salaries was also discussed, for the Village Clerk, Deputy Mayor, Deputy Village Clerk, and Senior Records Clerk. Trustees Blunnie, Pesante and Warbrick were in favor of the decrease and Deputy Mayor Downey was opposed.

These were discussions and no vote was taken. They were a consensus of the Board members. After several back and forth discussions, Trustee Warbrick suggested no raises for anyone and all members agreed.
